The Delicate Politics of Food

A venue that has had to struggle to survive, UBC Farm is a ten-year-old project that was until recently at the epicentre of the university's plan to create more condos on the endowment lands.

"There's more to growing food than the idea of eating locally-grown fruits and vegetables," said Andrea Morgan, a farm staff member and former UBC student. "A lot of folks come to the farm thinking just about eating locally, but end up learning about sustainable growth, as well as how food relates to things like the oil industry, pharmaceuticals, indigenous food sovereignty and so on."

According to Morgan, the educational and community value of

the UBC Farm's programming is one of the main reasons the farm needs to stay where it is. Even with constant pressure to turn it into condos, groups like Friends of the Farm rallied support from the student body and the municipal government to preserve the land as is.

"The idea of supporting the farm is something a lot of the student body got behind," said Morgan, "especially since food is

something everyone can relate to."

Struggles such as that of UBC Farm are at the centre of the ongoing We Ate the G8 counter-summit, being organized by students and educators against the G8 University summit in Vancouver, the latter of which encourages the ongoing commercialization of education.



Toronto Cops Kill, Media Complicit

On Sunday May 2, 2010, Sutikalh celebrated its ten year anniversary. Located halfway between Mt. Currie and Lillooet in southern BC, Sutikalh was at first a camp set up to stop a proposed \$530-million ski resort which threatened one of the last remaining untouched alpine mountain areas in the St'at'imc territory (the Cayoosh mountain range).

Approximately 75 people attended the anniversary gathering, which began with a spiritual ceremony conducted by Mayan supporters. After speeches by some who participated in establishing the camp, as well as supporters, a feast was served with traditional food, including salmon and deer meat.

Over the past decade, Sutikalh has been the site for many St'at'imc community gatherings, field trips by youth, berry-picking, etc. It is one of the most under-reported victories of grassroots Indigenous peoples, who succeeded in stopping the ski resort and defending their traditional territory.

FBI loses Marshall Case

An all-White jury in Rapid City, South Dakota, took less than two hours on April 22 to return a not-guilty verdict in the trial of former American Indian Movement (AIM) member Richard Marshall (of the Lakota Nation) in connection to the murder of fellow AIM member Anna Mae Pictou Aquash. The Federal Bureau of Investigation (FBI) claimed Marshall supplied the gun used to kill Aquash.

Vancouver resident John Graham, a Southern Tutchone Nation member originally from the Yukon, is facing trial in July over the Aquash murder. He was formerly Richard Marshall's co-accused but had his case separated and moved to South Dakota State court because the US federal government was shown by his lawyer to not have jurisdiction over him regarding a crime allegedly committed on the reservation. Graham's new co-accused is fellow former AIM member, Thelma Rios, and the trial is scheduled to start July 6.

The validity of Graham's extradition from Vancouver to a South Dakota prison was recently called into question by his lawyer when a government document was newly revealed advising prosecutors that in this case they did not have federal jurisdiction, which they willfully ignored and concealed from the defense.

No more Nakba!

Support Palestinians' Right of Return

On May 15, many Israelis will celebrate the 62th anniversary of Israel's 1948 "War of Independence". Palestinians and people of conscience worldwide remember May 15 as Al-Nakba ("the Catastrophe" in Arabic) – recognising the violent expulsion in 1948 of over 800,000 Palestinian refugees from their homes (75% of the population), and the destruction of 418 Palestinian villages. Annual Nakba commemorations are important events in Israel, where 20% of the citizens are Palestinian who experience the "ongoing Nakba" of apartheid-style policies including: land confiscation, discriminatory development planning, segregation and underfunding of Palestinian communities, home demolitions and forced evictions.

But now even that solemn rememberance is being targeted by the openly racist policies of the government of Israel. The Knesset's Law Committee recently approved a proposed law ("Nakba bill") that, if passed, would impose economic sanctions on the organizers of Nakba commemorations in Israel (the intial draft included criminal sanctions as well). In effect, the bill requires that Palestinian citizens of Israel deny their history and identity, and accept their current status as second-class citizens in a "Jewish state."

There are now more than 6 million Palestinian refugees whose right of return to their homes is denied by the state of Israel. UN General Assembly Resolution 194 states that "the [Palestinian] refugees wishing to return to their

homes and live at peace with their neighbours should be permitted to do so at the earliest practicable date, and that compensation should be paid for the property of those choosing not to return and for loss of or damage to property." This resolution has been affirmed by the UN over 130 times since its introduction in 1948 with universal consensus except for Israel and the U.S.

Walk and Rally for Salmon Survival

On Saturday, May 8, 2010, the largest public rally to date against fish farms occurred in Victoria, BC, following a 500 km trek by Alexandra Morton, a well known biologist who has campaigned for many years against the industry. The walk began on Earth Day, April 22, from Morton's home on Sointula, located off of North Vancouver Island.

The rally in downtown Victoria saw several thousand people gather, including many from First Nations heavily impacted by fish farms on west and north Vancouver Island, including the Kwakwaka'wakw and Nuuchah-nulth. Traditional drummers and dancers shared the stage at Centennial Square with environmentalists and entertainers.

After speeches and music, the rally made its way down to the BC Legislature to deliver its message to the government, along with petitions signed by citizens opposed to the fish farms. Despite the legislature being closed for the weekend, organizers were confident that those in government heard their message.

The walk and rally is part of a larger campaign demanding government and industry action

over the fish farms, which opponents claim is contributing to the ongoing depletion of salmon stocks. This includes infestations of sea lice, toxic chemicals, antibiotics and growth hormones associated with fish farms.

In mid-April, six First Nations launched a classaction lawsuit against the provincial and federal governments. In August 2009, an expected 10 million sockeye salmon in the Fraser River turned out to be less than 1 million, with the Department of Fisheries and Oceans, biologists, and government officials unable to account for the extraordinary depletion of the run.
